

# **Art Walk Summer Camp 2009**

## **Cost**

The cost of a five-day session is \$150 per child. This includes all required instruction fees and supplies. It does not include any meals.

## **Clothing Requirements**

Due to the nature of some of the classes, cotton clothing, and closed toe shoes are required. If the child has long hair, some sort of item to tie the hair back may also be required in some activities.

## **Participant Requirements and Behavioral Expectations**

Campers will treat fellow campers and instructors with respect and kindness. Campers will work safely and follow instructions at all times. Conduct that poses a risk to their own or others' safety will not be tolerated. Serious or repeated offenses will result in expulsion from the program, without refund.

## **Registration Information and Payment Policies**

The cost of camp is \$150 per child. Cash or Check only. Space is limited, so an early registration will help assure your child a place. Feel free to call to check space availability. We require full payment per child at the time of registration. Tuition is refundable up to 10 business days before the camp start date.

## **Cancellations/Withdrawals/Refunds**

A full refund will be given for cancellations made 10 business days or more before the camp start date. No refunds will be given for cancellations made less than 10 business days prior to the start of camp. No partial refund will be given if your child withdraws or misses days for any reason, or is expelled for misbehavior. If the registration minimum is not met 10 days before the camp start date, you will be notified.

## **Photo Release**

Photographs will be taken during the activities. These are used on bulletin boards, in brochures, for displays, etc. I hereby give my permission to the instructors of the Art Walk Summer Camp to use any photographs or videos taken of my child for the purposes stated above. It is further understood that all images of camp, it's campers, and staff are property of the artists and may not be used publicly without the expressed written permission of all artist instructors.

**WAIVER OF LIABILITY, MEDICAL RELEASE, & INDEMNIFICATION AGREEMENT**

In consideration for myself and my minor child being permitted by the Summer Art Walk Kids Camp to participate in activities described as attached, I hereby waive, release, and discharge any and all claims and damages for personal injury, death, or property damage which I or my minor child may sustain or which may occur as a result of my or my minor child's participation in these activities. I understand and agree that: 1. This release is intended to discharge in advance the employees and agents from and against any and all liability, except for their sole negligence or intentional acts, connected in any way with the participation of myself or my minor child in activities; 2. The described activity may be of a hazardous, strenuous, and/or physical nature; 3. Participation in the described activity may occasionally result in injury or property damage; 4. Knowing the risk involved, nevertheless I voluntarily request permission for myself or minor child to participate in the described activity; 5. I hereby assume any and all risks of injury, death, or property damage, and to release and hold harmless Happiness is Quilting, Art House, Stained Glass of McKinney, and Walls of Clay (hereinafter referred to as "Artists") involved, their officers, employees and agents, except for their gross negligence or intentional acts; 6. This waiver, release and assumption of risk is to be binding on the heirs and assigns; 7. I will indemnify and hold the "Artists" harmless from any loss, liability, damage, cost or expense, including litigation, which they may incur as a result of any injury and/or property damage which myself or my minor child may sustain while participating in said activities; 8. I will make good any loss or damage or cost the "Artists" may have to pay if any litigation arises on account of any claim made by said minors or by anyone on said minor's behalf; 9. In the event that said minor requires medical or surgical treatment while under the supervision of said associated artist personnel in connection with the described activity, such supervisor may authorize treatment; 10. I will pay all medical, hospital, or other expenses which I or my minor child may incur as a result of such treatment; 11. Activities are not child care as defined by the State of Texas. I certify that I have custody or am the legal guardian of said minor by court order, and that I and my minor child are physically able to participate in the described activities. I have carefully read this Waiver of Liability, Medical Release, and Indemnification Agreement and fully understand its contents. I am aware that this is a release of liability and a contract between myself and the "Artists", and that I sign it of my own free will.
